BASIC MEMBERSHIP INFORMATION

1. The Board of Directors meets monthly to review all applications for membership. Applicants' names are posted in the Club for 14 days for review by Club members. In case of any discrepancy with the Board or members, the prospective applicant will be notified. The General Manager may grant early access to the Club; however, final approval for all memberships rests with the Board.
2. The Club fiscal year is from June 1st to May 31st.
3. The entrance and transfer costs as well as membership fees are set by the Board of Directors.
4. All unpaid balances over thirty (30) days from statement date shall bear interest at a rate fixed by the Board of Directors.
5. Management and/or the Board of Directors has the right to place on no-charge, suspend and/or terminate any membership for non-payment of account or for behaviour detrimental to the enjoyment of the Club by other members.
6. By signing this agreement, you are acknowledging your continuing membership in the Royal Glenora Club. You will remain a member until such time as you notify the Club with **60 days written notice** of your intent to cancel.
7. If a Shareholder becomes inactive, the Shareholder shall be subject to repayment of the appropriate entrance/membership fees upon reactivation of membership.
8. All corporate accounts are to be guaranteed by the Corporation.

MEMBERSHIP APPLICATION PROCEDURES

1. Completed applications should be submitted to Membership along with payment (cheque, cash or major credit card).
2. Active shareholder membership applications (including Junior Executive and Corporate) should be accompanied by payment of the entrance fee, share and either the first month's fees or prorated annual dues. All costs are subject to GST.
3. Social shareholder membership applications should be accompanied by payment of the share and either the first month's fees or prorated annual fees. All costs are subject to GST.
4. Associate membership applications should be accompanied by payment of \$7000.00 deposit (junior \$2150.00/\$3500.00 deposit) and the first month's fees or prorated annual fees. All costs are subject to GST.
5. Corporate nominee transfer membership applications should be accompanied by payment of the appropriate transfer fee and either the first month's fees or prorated annual fees. All costs are subject to GST.
